1. The admission to Biotech Industrial Training Program (BITP) module will be confirmed only after the payment of the registration fee of INR 4000. The registration fee would be adjusted in the total fee at the time of joining of the industrial training.

Modes of Payment of registration fee (INR 4000)

- a) **Cash Payment:** The registration fee can be paid in cash at our corporate office between 09:00AM–05:00 PM (Mon-Sat)

2. The registration fee deposited is completely non-refundable and non-transferable. No communication or request in this regard would be entertained under any circumstances.
3. The balance fee has to be deposited at our corporate office one day prior to the commencement to the industrial training.
4. In case of late payment of the balance fee, late fee of INR 500 would be applicable.
5. The industrial training fee includes the cost of chemicals, reagents, consumables, and study material along with the taxes.
